In the upper left corner of the first page printed UDC (*font - bold*), below in a line: title of the article in lowercase without hyphens (*font - bold, alignment - center*) in Russian and English, below in a line: author's name and initials, city and place work, position, academic degree and / or title (*alignment - center*) in Russian and English, below: author's e-mail(s), below in a line: summary in Russian and English, below in a line: keywords in Russian and English.

A summary of no more than 3 lines should summarize the main subject of the article and its conclusions; the keywords (3 to 6 words) should reflect the agenda of the publication. Font: Italics, alignment: page width.

The text of the article should be aligned along the page width. When typing the text, make the hard return of words with a hyphen. All symbols and abbreviations should be defined at their first appearance in the text. The sections and subsections of an article should be numbered in Arabic numerals, in bold and not on a separate page.

It is necessary to differentiate the hyphen (-) (e.g., black and white, business plan) and a dash (-) (Ctrl + "-").

If you use quotation marks, they should take the form of so-called book qoutes (« »). If the text includes inner and outer quotation marks, they should be different, for example, of «"Publishing House "Macros"».

The tables in the text should be in Microsoft Word (not scanned and not a drawing). Tables should be located within the working area. Tables are not to be broken when continued on the next page (do not copy the titles, do not make spacing by pressing the *Enter* key). Tables are numbered from the top. Formatting the table number and title: *normal font, left alignment*. Table format: *normal font, font size 12 pt, alignment: centered, line spacing: single*.

Pictures are placed within the working area. You can use pictures in JPEG and GIF. They should allow movement in the text and changing size, and be represented as a single element. Scanned images used in the text should have a resolution of 300 dpi. *Picture position*: in the text. Figures are numbered from the

bottom, captions are centered.

#### **EXAMPLE:**

## Figure 1 – Picture title

Number of tables in a document: no more than 3, number of drawing: no more than 5.

Formulas should be typed using the formula editors Microsoft Equation 3.0 or Math Type, center aligned; their numbers: in parentheses on the right.

Page numbering, headers and footers are not allowed.

The references in the text are to be in square brackets indicating the number of the source, such as: article ... [1]. Article ... [2], etc.

References are to be listed at the end of the article and should be entitled "References" (*bold font, center alignment*). The sources used must be formalized in accordance with GOST 7.1-2003 (*page width alignment*).
